

Privacy Policy

Protecting your private information is our priority. Collection of your Personal Information

In order to better provide you with products and services offered on our Site, TTDAT may collect personally identifiable information, such as your:

- First and Last Name

If you purchase TTDAT's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
